#### Stakeholder Workshop:

**Towards a professional academic qualification on Children's Rights:** an opportunity for networking, discussion and contributing to the design of a new European Master programme Date: September 28, 2006, Location: University of Amsterdam

The European Network of Masters on Children's Rights (ENMCR) is developing a new, international and interdisciplinary MA study program on children's rights, which is to be offered starting in September/ October 2007. In order to link this Master as close as possible to existing needs and expectations in the work field, we are organising a participative stakeholder workshop at the University of Amsterdam on September 28, 2006. In the workshop, organisations will have the opportunity to exchange experiences with other stakeholders, and in this way both contribute to and gain new insights on further qualification of professionals in the field of childhood and children's rights. The meeting will provide a unique opportunity for NGOs and public agencies in Europe to ensure that their organisations' thoughts, requirements and wishes are reflected in the development of the planned joint MA curriculum on children's rights. The workshop, including lunch and a dinner buffet, is free of charge; travel expenses however are not covered.

The program consists of a plenary program in the morning and a number of workshops in the afternoon. First our plans regarding the new European Master will be presented. Thereafter a number of key stakeholders from different fields (NGO, EU, Youth and Academia) will present their ideas and suggestions for the program. The stakeholder presentations are meant as a first inventory of views and opinions, they will serve as a starting point for discussion. These discussions will then be developed further in the afternoon workshops.

• WG 1: Cooperation between practice and academia- possibilities for long term cooperation, staff qualification, contracting possibilities

The aim is to define what staff qualification is needed by the professional world and what can be offered by the Master. Furthermore, different models of long term cooperation between the European Master and the professional world will be discussed.

• WG 2: Children's participation; what does it mean, how can it be achieved?- methods, cases, best practice examples

The objective is to find out, what skills and working tools graduates of a European MA on Children's Rights should have in order to find solutions for realising effective participation of children in society and in formal political processes, in order to include imparting of this knowledge and tools in the Curricula of the MA.

• WG 3: Children's Rights in Europe/ in the EU- What are the main issues concerning children's rights and their implementation on a European level? In how far can the European Master address perceived deficits and contribute to the improvement of children's rights in Europe?

The working group will be moderated by a member of the European Parliament and a representative of ENMCR. The objective is to discuss children's rights on a European level and elaborate on possible contributions of the European Master programme to improve the situation. What skills and resources are needed to strengthen children's rights on a European level?

• WG 4: Children's Rights as an international responsibility-

What tools and what competences are required to address children's rights in a global context? The European Master on Children's Rights not only addresses the issue of children's rights on European and national levels within the EU but views childhood and children's rights in a global context. The objective of the working group is to define what tools and what competences are required to meet the international responsibility to contribute to making children's rights a reality worldwide.

There are still some few places left for the workshop, we would like to encourage NGO and public agency representatives to join us.

Report on 3 Sat online: Minor children working fulltime are not necessarily also unhappy childrento work in order to nourish the family: for many children this is completely ok

On 3 sat, a German public TV station, a report was shown on how children who work fulltime find pride in their work and are happy to be able to support their families- this stands in stark contrast to the general view of child labour being always bad and having to be eradicated. ENMCR member and expert on working children, Prof. Manfred Liebel (INA-FU, Berlin) was surprised himself in the beginning to hear, that children take pride in their work and even have fun. But through talking to the youngsters, a different view of the working children and their situation evolved, which needs to be brought into public more vehemently, the report on 3 Sat online is a good start to the endeavour of giving an insight into the children's perspective, who more often than not are not even asked for their opinion even on issues that concern only them. What is needed is protection of the working children, not a prohibition of child labour, which criminalizes the working children and pushes them into illegality and hazardous working places.

#### Training workshop: Children's Rights in Practice: Tools for Social Change

Date: February 25 - March 2, 2007 Location: Victoria, British Columbia, Canada

The International Institute for Child Rights and Development (IICRD) will be hosting a week long interactive conference on Children's Rights in Practice. Topics to be addressed in plenary and workshop formats by presenters and keynote speakers include the social ecology of children's rights with special focus on: Children as Partners: Child participation; Children at Risk: Building on children's natural resiliency and protection; Child Rights in the Context of Culture: Indigenous child rights; Practical tools for use in everyday settings: Effectively implementing children's rights in everyday practice

Special emphasis will be placed on learning and sharing child-centred, creative tools promoting social change in support of child rights. The conference will emphasize a learner-centred approach featuring: Key expert presentations; "Open space" learning and sharing format; Small group specialized discussions; Opportunities for informal learning and sharing

The conference will take place in an inspirational, natural surrounding conducive to personal and professional growth and the deepening of social relationships and child-centred networks. #### Petition against the use of children for begging

Trafficking in children is on the increase and is touching the heart of humanity. In Europe many criminals are using poverty to their advantage to traffic human beings in the same way as arms or drugs. According to the NGO Terre des Hommes every year over 1 million children are victims of trafficking all over the world. They are exploited for sexual aims and pornography, domestic and industrial slavery, traffic of organs, illegal adoption, criminal activities such as stealing, drugs, etc.

In Belgium a group of individuals have launched a petition to sensitise both government and citizens to the need of countering this form of organised crime and to help all victims, with special attention to children. All children need and have the right to total protection by the law, without discrimination and independently of their family or legal situation. They are particularly highlighting the complex issue of child begging.

#### Dutch Government Allows Establishment of Paedophile Political Party

In May 2006 a new political party was formed in the Netherlands: the PNVD (Party for Neighbourly Love, Freedom and Diversity). The founders of this party are paedophiles, and as such they are well known to the police and the authorities. They are members of Martijn, an organisation for paedophiles, which was recently reported to the police by the National Reporting Point for Child Pornography, for grooming children for sex on internet sites.

The PNVD party programme includes the following: lowering the age of consent for sexual acts between children and adults to 12 years; making participation in child pornography legal from age 16; legalisation of child pornography with quality control; allowing children to smoke, drink and gamble from age 12. The party programme lends an air of legality to its activities and by cloaking their agenda in the language of

children's 'right to sex', there is a very real danger that they could convince outsiders to vote for them. By giving sex with children an air of normality, the PNVD creates a climate that leads to abuse of children. The PNVD appeals to the right to freedom of speech. But Article 10 of the European Treaty for Protection of Human Rights and Fundamental Freedoms emphatically states that freedom of speech can be made subject to conditions, limitations or sanctions, in order to protect the rights of others, public health and morals. Freedom of speech and freedom of sexual orientation are rights of a different order. Paedophilia has only to do with abuse of children. According to several law experts, the Dutch government could ban and dissolve the PNVD, based on Article 20, Book II of Civil Law, defining it as being against the public order. But the Dutch government refuses to interfere, stating that democracy is more important than protecting children, and that he will only interfere if and when the members of the PNVD commit illegal acts. There is currently no investigation into the party or the founding members. The Foundation Profit for the World's Children is a children's rights organisation in the Netherlands which objects to the intended formation of the PNVD and requests that the Dutch government take appropriate measures against this party of paedophiles. It urges the international community to sign a petition, react and send their statements to the Dutch government and press. #### Index of child well-being in the EU

In the framework of Research on Social Indicators in Europe, Jonathan Bradshaw, Petra Hölscher and Dominic Richardson have published an *Index of Child well-being in the European Union*. While the living conditions of children and young people in the EU have gained increased recognition, the wellbeing of children is not monitored on the European level. Based on a rights-based, multi-dimensional understanding of child well-being, the authors analyse data available for the EU 25, using a series of data as well as comparative surveys of children and young people. #### Refugee children: Guidelines on determining the best interests of the child

The UNHCR Guidelines on Formal Determination of the Best Interests of the Child are part of the commitment by UNHCR to disseminate materials on the rights of refugee children, drawing on the Convention on the Rights of the Child and other international human rights law. Information collected from a variety of reports, including the Annual Protection Reports, as well as through participatory assessments, indicates that there is no consistency among field offices as to when and how Best Interests Determinations should be carried out. COURSE: Working Effectively Within a Rights Based Approach [event]

Date: 12 - 13 September 2006, Location: London, UK

The aim of the workshop, which is organised by BOND, is to give delegates a chance to learn tools and exchange practical advice on mitigating common issues encountered when operating within a Rights Based Approach. A Rights Based Approach has become a popular overarching philosophy for many development NGOs and donors. Increasingly, NGOs are forced to take on a Rights Based Approach when they enter into funding agreements with donors. Difficulties can arise if NGOs have not taken into consideration how this new approach could impact the aims of their organisation, how they operate, or with whom they engage as partners. This course will give delegates the opportunity to swap strategies and learn new tools and methods to offset these common problems.

By the end of the workshop, participants will be able to:

- Describe the key principles that guide a Rights Based Approach.
- Explore how these principles have been applied to organisations, programmes and specific thematic areas, such as education; capacity building; HIVAIDS or other areas that concern delegates.
- Focus on current debates and dilemmas around the Rights Based Approach.
- Investigate methods of offsetting common problems encountered using a Rights Based Approach within the context of their own working situations

**SOUTH EAST EUROPE: Preventing child trafficking – preliminary assessment** [publication] Piecemeal prevention efforts in South Eastern Europe (SEE) are failing to protect children from falling prey

to traffickers and have relied too much on general awareness-raising, says a report released THIS WEEK by UNICEF and Terre des Hommes which also urges a shift of focus away from prosecution.

The report Action to Prevent Child Trafficking in South Eastern Europe - a Preliminary Assessment examines different strategies and initiatives to prevent child trafficking in SEE and it includes the voices of child victims from Albania, Moldova, Romania and the UN Administered Province of Kosovo where the research was carried out. The report finds that awareness-raising campaigns are often way off the mark, are unfocused and not systematic. Some carry stereotypical images of men lurking in the shadows when traffickers are often family or friends; others ignore trafficking for purposes other than sexual exploitation, for example, domestic work, begging or stealing; that most messages are tailored to adults instead of children and therefore provide little or no information on how children might protect themselves, who to turn to, or where to go for help. Child trafficking can only be combated by addressing the root causes of the problem and the patterns of supply and demand that govern the cycle, the report states. The report calls for the establishment of harmonised, synchronised and seamless systems and services – both internal and cross-border – to protect children. It stresses the obligation in this regard on States and on parents, guardians and professionals who interface with children (customs officers, border guards, police, teachers, social and health workers etc) under the UN Convention on the Rights of the Child and other relevant instruments. In addition, standardised, comparable indicators and data must be gathered and shared broadly across international boundaries. #### **GRANTS FOR RESEARCHERS**

The European Commission supports transnational research activities carried out by researchers. More in particular, the European Commission provides grants to universities, institutions or associations organising the mobility of researchers who are seeking to enhance their research by spending a period at a host university in another country. The researchers must be in possession of a degree giving access to doctoral studies or may be post-doctoral. All applications must be submitted by the home university of the researcher or by the association or network of university lecturers that is responsible for the transnational research activity. Applications that are submitted directly by individuals will not be accepted.

The European Commission's financial assistance is in the form of co-financing. Grants may not exceed 50% of the total cost. Grants consist of a flat-rate payment of € 1.000 per month for a maximum of six months. Additional assistance of up to € 1 000 for travelling costs actually incurred may also be paid.

A flat-rate contribution not exceeding € 1.000 may also be granted for the costs incurred by the host university. In the case of applications submitted by associations and networks of university lecturers, additional assistance of up to € 2.000 to cover selection costs actually incurred may also be paid.
