Request for feedback by FRA

The European Agency for Fundamental Rights (FRA) launched a consultation requesting feedback and suggestions for follow-up on its annual report 2008 and ideas for the 2009 work programme. Replies should follow questions in the questionnaire as relevant for the activities of respondents. The

FRA was built on the former European Monitoring Centre on Racism and Xenophobia (EUMC). It has continued the work of the centre in those areas but in the context of a broader mandate established under a Multi-annual Framework (MAF) http://eur-

<u>lex.europa.eu/LexUriServ/LexUriServ.do?uri=OJ:L:2008:063:0014:0015:EN:PDF</u> covering the period 2007-2012. Each year the agency carries out its mission in the light of an Annual Work Programme based on the thematic areas that were determined in the MAF.

The information in the annual report 2008

(http://fra.europa.eu/fra/index.php?fuseaction=content.dsp_cat_content&catid=4860badc7f081) relates to data and analysis on developments in the fight against racism, xenophobia and related intolerance in the EU in 2007. Across the report the situation of children is also addressed. The report confirms that most vulnerable children - children of Roma, Sinti, Travellers, asylum seekers and irregular immigrants - experience racism and discrimination in the areas of education, access to healthcare and housing. Findings indicate those children experience racist violence, face difficulties in accessing healthcare facilities, and are confronted with unfit education systems that cause segregation and unequal opportunities. Examples of racism and discrimination against children as well as 'good practice' examples support the conclusions of the report.

According to the 2008 work programme,

The agency will continue collecting data and carry out research on the situation regarding the rights of the child and will launch two new projects:

- on "Legal instruments and judicial data regarding the protection, respect and promotion of the rights of the child in the European Union";
- a "Comparative report on the situation regarding the protection, respect and promotion of the rights of the child in the European Union.".

FRA will also carry on a project launched in 2007: "Study on indicators measuring the implementation, protection, respect and promotion of the rights of the child in the European Union, mapping and assessment of available relevant data resources."

Commission launches competition open to all young people in the European Union

"The right of the child to protection" is the title of a competition launched on 31 July, by Jacques Barrot, the Commissioner for justice, freedom and security. European children and adolescents aged 10-18 are invited to design a poster on the right of children to protection in the EU. The aim of the competition is to ensure that young European citizens are more aware of their right to protection and are better equipped to defend it.

France to put its children on file

Minors "likely to cause public disorder" could be file as early as 13 years old in a police database according to new French legislation issued on 1st July. The new file called "EDVIGE" will include young people's personal data such as civil status, physical and electronic addresses, as well as personal characteristics, such as behaviour. The French institution CNIL (National Committee on Information and Liberties) has expressed serious concerns about the database. In a resolution adopted on 16th June, it stated that "the treatment of such data calls for strong guarantees and must be carefully monitored". "EDVIGE" currently belongs to the Central Direction of Public Security, which was recently restructured and took over some competencies of the French Information Agency, mainly in terms of demonstration surveillance, urban troubles and social conflicts. However, up to now the Information Agency's databases only concerned adults. Source: www.service-public.fr

Switzerland: vocational training for undocumented young people

The Swiss Christian Democratic Party (PDC) has proposed in a motion deposed at the Grand Conseil on 9 April to open vocational classes also to undocumented children. This measure would concern only undocumented children who have carried out their schooling in Geneva. "Particularly those that, 15 or 16 years old, have already found an employer ready to engage them for an apprenticeship and are blocked because of their status", said the MP Anne-Marie von Arx Vernon, recalling that the undocumented children already have, on the other hand, access to professional school. New Convention on adoption (Committee of Ministers of the CoE)

A new convention on child adoption was recently adopted by the Committee of Ministers of the Council of Europe. It updates the 1967 Convention, improving the procedure for national adoption and making it more transparent, efficient and resistant to abuse. It also improves the conditions for international adoption. The aim is to take account of social and legal developments while respecting the ECHR and giving precedence to the child's best interests. Among the new provisions introduced by the Convention are:

- The father's consent is required in all cases, even when the child was born out of wedlock.
- The child's consent is necessary if the child has sufficient understanding to give it.
- It extends to heterosexual unmarried couples who have entered into a registered partnership in States which recognise that institution, and to single people. It also leaves States free to extend adoptions to homosexual couples and same sex-couples living together in a stable relationship.
- The new convention strikes a better balance between adopted children's right to know their identity and the right of the biological parents to remain anonymous.
- The minimum age of the adopter must be between 18 and 30, and the age difference between adopter and child should preferably be at least 16 years.

International Conference and Training "Ending Violence against Children in Juvenile Justice Systems: From Words to Action"

Date: October 1-3, 2008 Location: Brussels, Belgium

"No violence against children is justifiable; all violence against children is preventable"

This is the key message of the United Nations Secretary-General's Study on Violence against Children, the aim of which was to report on the scale of violence against children in five settings: home and family, schools, care and justice systems, the workplace and the community, and to make recommendations for combating the practice within each context.

The aim of DCI's conference is to address the Study's recommendations for ending violence against children in institutions – and more specifically, in juvenile justice systems. While the UN Study found violence to be rife across all five social settings, the violence experienced by children in care and justice systems is particularly challenging as it remains hidden from the public eye and affects some of the most disadvantaged groups of children in society.

The objectives of the conference are thus to raise awareness, share best practices and build the capacities of NGOs to lobby their governments to act. This conference is structured with plenary sessions followed by thematic workshops and practical training to mobilise civil society in pushing for less words and more action in ending violence against children. www.dci-conference.org

Several of CRnews subscribers have met representatives of this group during the ESF workshop held in June this year. Germany, with its provisos to the UNCRC upholds the right to treat German children differently than non-German children. The demonstration on the Day of the CRC wants to contribute to making the written papers, namely that all people have equal rights, a reality for all people in Germany, regardless of their status or nationality, race, religion or age.

FRA's first Annual Report

The Fundamental Rights Agency presented its first Annual Report to the European Parliament's Committee on Civil Liberties, Justice and Home Affairs (LIBE) on 24 June 2008. The new FRA report summarises the findings of the Agency's ongoing data collection through its RAXEN National Focal Points (NFPs) in each of the 27 Member States of the EU, highlighting also examples of good practice. The Agency's Director, Morten Kjaerum, and Chairperson of the Management Board, Anas-

Report on Education, Youth and Culture Council (EYC), Brussels, 21-22 May 2008

In their May meeting in the European Council, Youth Ministers adopted a Resolution on the participation of young people with fewer opportunities. The Resolution is the result of process involving consultation with civil society, with young people themselves and a peer-learning exercise between member states. The over-riding message is that the situation of young people with fewer opportunities in Europe is extremely worrying and deserves greater political attention both nationally and at EU level. Thematic Working Group on Early years – new resources uploaded!

Check out the new publication from the Bernard van Leer Foundation in collaboration with the Open University: "Early Childhood: Transitions research - A review of concepts, theory, and practice". Now available at the resource section of the TWG on early years webpage!

Children face many important changes in the first eight years of life, including different learning centres, social groups, roles and expectations. Their ability to adapt to such a dynamic and evolving environment directly affects their sense of identity and status within their community over the short and long term. The paper provides a review of the major perspectives in research on early childhood transitions and reveals the predominant areas of focus in both academic and professional studies, as well as important neglected viewpoints and study populations.

Commission presents annual report on education systems

On 10 July the EC presented the annual report on the progress made by member states towards the goals set for education systems under the Lisbon strategy. Data shows performance on completion of secondary education, early school leavers, low achievers in reading literacy, graduates in maths, science and technology and the participation of adults in lifelong learning activities. The report concludes that progress has been made although efforts need to be increased to achieve the 2010 targets.

It offers an in-depth review on the integration of migrant pupils, the evolution of the politics in the educational institutions, the attitudes of students, parents and teachers, set against the new reality. Belgium Observatory of Childhood, Youth and Youth Support 2007 annual report

The Belgium Observatory of Childhood, Youth and Youth Support recently presented its 2007 annual report to the French Community Government and Parliament. The Observatory has undertaken an evaluation of child's rights in Wallonia and continued to monitor policies and conduct research on indicators of child well-being and child participation among other topics. It has also strengthened its actions within the wider network ChildONEurope. In a survey on the participation of children from 10 to 18 in Wallonia, they found that within families, three children out of four give their opinion on decisions affecting them, and they say their opinion has an influence.
