#### Lecture Series: Child Rights and School (German)

**Dates:** every other Wednesdays from 6-8pm, starting: **26 November 2008; Location:** Grundschulwerkstatt of the Humboldt-University Berlin, (Geschwister-Scholl-Strasse)

If children have rights, then they also have the right to organisation and structure of school and classes that abide to these rights. This is the core thesis of the lecture series. This thesis becomes necessary, as in the area of primary schools, the subject of children's rights has almost exclusively been a subject dealt with in German or social studies classes. But where is the right of every child to participate in all matters affecting him or her? Which primary school involves children in choosing which learning materials are used (to name but one example of rights from the UNCRC). The lecture series aims at weighing opportunities and chances to understand children's rights not only as subject in school but as organisational and didactical principles in schools. #### 20th Anniversary of Instituto Generación (Peru)

The Instituto Generación, an organisation for and of children living in the streets, is looking back at 20 years of social action with the most neglected children in the city of Lima, Peru. After its first 20 years, Generación finds itself full of positive energy, which is nourished by the hopes of the children and young people who are striving for a life in dignity. The institutional experience has been one of fighting for and meeting basic needs, of struggling to live the catalogue of rights that are in place for the children and by this recuperate the dignity which in many cases has suffered from poverty and maltreatment. Generación also looks back on 20 years of struggle against state intervention and aggression which derived mainly from false accusations, especially in the media, which create a great fear and doubt about children and young people living in the streets. According to international human rights conventions the state is obligated to guarantee the social and juridical protection also to children living in the streets. Generación has fought and keeps fighting for the fulfilment of these obligations basing its main objective on Paulo Freyre's statement that "History is something that can be made and remade by ourselves." #### Survey: opinions on child-friendliness in Germany

The majority of German citizens believes Germany to be a non-child-friendly country. The findings of a survey run by the institute FORSA revealed that 40% of respondents believe Germany to be child-friendly, whereas 56% voted with "no". However there are major differences between East and West Germany. Round about 65% of East Germans complain about child unfriendliness compared to 56%

in Western Germany. Even greater disparities are revealed when looking at the age structure of respondents: 56% of the 18-29 year olds believe Germany to be child friendly, whereas the ratio is nearly the other way around in respondents aged 30-44 years old. In this age group, 60% experience Germany as being child unfriendly.

#### 46 Members of German Parliament demand rights to vote for children

The title sounds better than it is. Even though members of parliament from all political parties stand behind this demand, they are demanding a right to vote for children which is practiced by discretion of their parents. Even though the initiative is a first start to meet the demand of many children and in particular youth who are interested in politics for them to have a voice, the mechanism strived for, to have the parents vote for their children, cannot be the end solution. Children and young people may disagree with their parents' opinions, they may feel yet excluded by not being able to vote themselves and the opportunity for parents to have an extra vote for every child may also create wrong incentives.

"Free of fear and distress?" Children's Rights between Claim and Reality - A seminar of the Academy Frankenwarte in cooperation with amnesty international (German)

#### Date : 26-28 September 2008; Location: Würzburg, Germany

The CRC is the most rapidly signed and ratified international human rights convention ever. However what looked like an obligation to the fulfilment of the rights of the child has revealed itself to be a semi-truth only. Still millions of children suffer from severe child rights violations and only few of these are known to the world public.

Amnesty international has worked increasingly on the issue of child rights violations since 1999 and the seminar aims at introducing the work done. First, the history, meaning and contents of the UNCRC will be imparted, the work of the UN Committee on Children's Rights will be discussed. In discussions an overview will also be given of other instruments for the protection of children. Thereafter the seminar will deal with three topics that are focus themes in ai's work: 1. Armed conflicts; 2. The right to education and 3. Human Rights violations in the juvenile justice systems. Registration: Akademie Frankenwarte z.Hd. #### International declaration of blind and partially sighted children

In June 2008, the First International Congress for Blind and Partially Sighted Children took place in Spain. The participating children set up a declaration after having evaluated their current situation. In the declaration several recommendations for the improvement of their situations and their quality of life are made. Firstly the declaration reinforces that children who are blind or partially sighted have the same rights as any other child, whereas an emphasis is put on those rights which are particularly prone to be violated in respect to blind or partially sighted children. Above all, non-discrimination is demanded as well as access to special provisions. The children also request that the governments and organizations representing their rights allocate funds for organizing events for the benefit of the children in their respective countries and they recommend that there should be at least one teacher in every school with the necessary capabilities to provide an equal education opportunity for the child. #### **ENOC:** Concerned over EU Return Directive

The European Network of Ombudspersons for Children (ENOC) is deeply concerned about the recent agreement reached by the European Parliament and the Council of E.U. on the 'Return' Directive (June 18, 2008) and calls on national governments to transpose it by respecting fully and without any exceptions the rights of children and the safeguards for their full enjoyment by foreign minors, especially those unaccompanied. The Directive provides grounds for the violation of children's rights, despite including vague clauses for respect of fundamental rights, special treatment of vulnerable groups and due consideration to the best interests of the child.

Those clauses right next to provisions allowing detention and expulsion of unaccompanied minors seem to be rather wishful and do not guarantee the prevention of children's rights violations.

The grouping children under the vague and general title of 'vulnerable persons' (art.3), which is also true for other categories, inevitably leads to downgrade the child's condition and absolute right to protection. Further information:

#### BRAZIL: World Congress III against Sexual Exploitation of Children and Adolescents Date: 25 to 28 November 2008, Location: Rio de Janeiro

The Government of Brazil, ECPAT International, UNICEF and the NGO Group for the Convention on the Rights of the Child are preparing for the World Congress III to be held in Rio de Janeiro from 25-28 November 2008. Participation of governments, civil society, UN, private sector and other key stakeholders from all regions of the world is expected. The World Congress III is considered as an important next step in the continuing effort for realisation of children's rights which started with the mobilisation for the First World Congress coinciding closely with the CRC, followed by the renewed commitment of governments in Yokohama in 2001 at the occasion of the Second World Congress. The World Congress 2008 is an important opportunity to renew global commitment to combating sexual exploitation of children and to galvanise international will and support for the concrete action required. The Congress helps to maintain the global focus on the specific problem of sexual exploitation of children, allowing stakeholders to analyse, refine, re-tool and recommit to both action agendas for the elimination of CSEC.

Five major themes have been selected to be discussed at the world congress: 1. Forms of Commercial Sexual Exploitation and its New Scenarios. 2. Legal Frameworks and Responsibility. 3. Integrated Inter-Sectoral Policies. 4. Initiatives of Social Responsibility. 5. #### EUROPE: Migrant children and education: a challenge for EU education systems

A Green Paper adopted by the <u>European Commission</u> opens the debate on how education policies may better address the challenges posed by immigration and internal EU mobility flows. The presence of significant numbers of migrant children has substantial implications for European education systems. Key issues are how to prevent the creation of segregated school settings; how to accommodate the increased diversity of mother tongues and cultural perspectives and build intercultural skills; how to adapt teaching skills and build bridges with migrant families and communities.

The Green Paper undertakes a brief review of policies and approaches that may foster educational success for migrant pupils. It indicates that those systems which strongly prioritise equity in education are also the most effective in integrating migrant pupils. Among the policy measures which seem particularly useful to address the issue are pre-school education, language learning, additional educational support such as mentoring and tutoring, intercultural education as well as partnerships with families and communities. The Green Paper aims to foster an exchange of views on how to address these challenges at all levels, and also to inquire how the EU might in future support Member States in formulating their education policies in this area. Interested parties are invited to make their views known about the policy challenge, policy responses, and the possible role of the European Union in supporting Member States, **before 31 December 2008**. The European Commission will analyse the results of this consultation and publish its conclusions in early 2009.

## Childhood, Transition and Social Justice- Postgraduate Research Studentships, Queen's University, Belfast

*Childhood, Transition and Social Justice* is an exciting new initiative exploring the lives of children and young people in Northern Ireland. It is directed by Professor Phil Scraton and a Research Fellow will be appointed. Within this initiative two full-time, three-year postgraduate bursaries are to be awarded linked directly to already established and ongoing research: *Understanding the Lives of Children and Young People in the Context of Conflict and Marginalisation* (see below for further details). Proposals are invited on any topic relevant to this work. They should have a Northern Ireland focus, demonstrate a clear understanding of critical analysis and a commitment to qualitative methodology. They should anticipate how the research will make a distinct contribution to knowledge and understanding of the rights of children and young people.

Proposals should be no more than five pages and include the following:

- Working title
- Brief description of the proposed project establishing why it is significant and its intended contribution to knowledge.
- Brief review of the theoretical literature relevant to the proposed project including critical theories of childhood and children's rights.
- Research question/s to be addressed by the research
- Proposed methodology including qualitative research methods to be used

- Brief bibliography
- Two academic referees

Details of the ongoing project, Understanding the Lives of Children and Young People in the Context of Conflict and Marginalisation, to which the studentships are linked, are available <u>here</u> and applications will be assessed with regard to their relevance to the development of this work.
