Workshop on Teenagers' Actions and Interactions Online in Central and Eastern Europe: Potentials and empowerment, risks and victimization

Date: 23 – 25 May 2008; Location: Cluj-Napoca ROMANIA, Social Work Department

The idea that the new communication technologies are able to create new social practices and to shape human behaviour has stirred up multiple controversies and radically opposed side takings, especially when it comes to certain social-demographic categories seen as "risk-prone". Recent tendencies in the evolution of computer mediated technology and web content have led to the rejection of a rigid technological determinism and instead, they have shifted the discourse towards a consideration of various

influences on behaviour and actions, both online and offline.

Our seminar proposes a documented insight into various issues related to teenagers' actions and interactions online in CEE: potentials for skills development, empowerment of the oppressed youth, as well as risks of online oppressive behaviours and victimization effects of the online environment. We are interested in identifying new types of teenagers' online behaviour, gratifications and effects generated by the Internet (Web and CMC), with an emphasis on specific problems and risks. Special attention should be given to the gender perspective and ethnicity in the context of Internet use.

The seminar aims at bringing together a rich diversity of research approaches, quantitative and qualitative, in order to:

- 1. differentiate typologies and patterns of Internet associated performances among teenagers,
- 2. develop a prevention model to counterbalance the online oppressive/victimization phenomenon,
- 3. build a network of researchers and professionals who are willing to research and act for encouraging the useful potentials and empowering effects of online behaviours, to work and consult together in order to stop or at least to prevent online oppressive/victimization phenomenon.

CALL FOR CONTRIBUTIONS: We invite proposals for papers that might enable the exploration, description, critiques, comparative aspects in the proposed thematic area, theoretical as well as empirical approaches. Contributions that address more than one theoretical perspective and cover different areas within the social sciences are highly welcomed (sociology, social work, psychology, media and Internet studies).

Deadline for submission of abstracts (800 words): January 31, 2008.

Full text papers should be submitted by **April 15, 2008**.

International Conference: Child and Youth Research in the 21st Century: A Critical Appraisal **Date:** 28 - 29 May, 2008; **Location:** European University Cyprus; Nicosia, Cyprus

Organized by the *International Childhood and Youth Research Network*, of which ENMCR is a member (www.icyrnet.net) Though child and youth research is fairly new and much more work is needed to assess its impact, a critical look back and into the future can help us appraise its role in the contemporary world. One of the main aims of the conference is to critically explore the intersection between research, policy, and practice by facilitating a dialogue between the different perspectives.

Some of the questions conference participants may wish to reflect on are:

- What are the methodological and ethical challenges of child and youth research and what can we learn from an interdisciplinary dialogue on methodology?
- What is the role of child and youth studies programs in the development of the next generation of researchers?
- How does the politics of research with children and youth shape the research agenda and policy priorities?
- How can research inform and/or change popular understandings of children and youth and how can research knowledge be made more accessible to the public?
- How does child and youth policy at the national level intersect with policy at other levels (e.g., the European or international levels) and what is the role of NGOs and other institutions in policy-

making?

• What can policy makers learn from child and youth researchers and their focus on children's and young people's voices? What can researchers learn from practitioners? What can practitioners learn from policy makers?

The conference organizers welcome proposals from academics/researchers, policy makers, practitioners, as well as others who work on childhood and youth from all parts of the world and from all disciplines. 10th Nordic conference for youth research: Bonds and Communities- Young people and their social ties (Call for papers)

Date: 13-15 June 2008; Location: Lillehammer, Norway

The biannual NYRIS-conference offers the opportunity for all with an interest in youth research. Social bonds and social networks are important to young people – for their well being, for their development and their future trajectories. In early years, parents and extended families represent the most important social bonds and resources in the life of young people. As they grow out of their childhood and into their identity formation years, social peer networks are of growing importance. At the same time, local as well as globalised communities are contexts for family ties, friendships and other relationships. The 10th Nordic Youth Research Information Symposium wants to highlight young people's social ties – from the closest of dyads to the most distanced of the global, from the nourishing to the destructive.

In high modernity, the fear of social disintegration, breach of tradition and social cohesion is evident in social research in general and youth research in particular. Risk society and events of terror produce complex reactions, reasoning and emotions and challenge community in multicultural neighbourhoods and societies. Each individual depends on social capital in their identity development, building blocks shaped by gendered, ethnic and localized relationships as well as social class and family backgrounds. Young people's mental health, development and well being is related to the quality and nature of their relationships. A holistic approach to young people's lives includes the support, resources and potential which lie in their own social bonds.

NYRIS10 welcomes papers and presentations that can contribute to new insights, empirical evidence and critical thinking on bonds and communities of young people, as well as other topics. Dialogestan - Young People for Human Rights

The Berlin Development Education and Information Centre (EPIZ e.V.) is now launching its new human rights education project, "Dialogestan – young people for human rights". The aim of this peer education program is to bring young people, aged 16-22 years, together to learn about human rights and to develop competences to function as multipliers for human rights within their local communities.

Several workshops are going to be held in 2008/2009, including an introduction to human rights, an intensive course about a relevant human rights issue such as gender discrimination and a session focusing on presentation and journalism.

Based on a participatory approach, the project offers lots of opportunities to develop ideas about

Declaration of children and young people at the 3rd World Congress on Children's Rights The 130 children and young people from more than 20 countries who participated in the 3rd World Congress on the Rights of the Child which took place in Regulator from 14.10 November 2007

Congress on the Rights of the Child which took place in Barcelona from 14-19 November 2007 managed to elaborate an astounding declaration with recommendations on the following themes: Poverty, Health, Abuse, Identity, Education and Participation.

Concerning **poverty** the declaration states that the children believe it is avoidable and they offer ideas for solutions on how to abolish poverty. The main issue they raise is to invest governmental funding in education and training, as well as health centres and not in wars. They also highlight the use of poverty as excuse for non-action.

Health: The children and young people acknowledge the fact, that nutrition is an important factor for health. Where children in the Global South suffer from malnutrition, young people in the Global North face health difficulties due to obesity. They demand the right to health for all, especially for those living in remote, rural areas of the world; also, reference is made to the discrimination towards homosexuals, which in the children's view results from ignorance of the illnesses these people suffer from. They demand the introduction of methods to raise awareness about these issues. Emphasis is laid on the mutual development of methods, by actors from the North and the South.

Abuse: The children point to the many children who suffer from abuse and acknowledge the impeding effect thereof for socialising and relating to their environment. Many children do not know they have rights and demand states to include child right education in schools- especially concerning the situation of institutionalized, refugee, migrant children.

Identity: All children and young people are in a stage of formation. In order to be able to form their own individual identity, the children demand active fight against all forms of discrimination and to establish a space for communication between cultures in order to develop a better understanding of all being equal.

Education: Education is the key to non-discrimination and to participation in society. Yet, schools as lead today are often privatized and therefore inaccessible for many children and/or the structure of teaching is adult-centred and undemocratic. Children demand from governments to respect and implement every child's right to education and ask for teachers to be regularly trained to meet the demands of multicultural settings and participatory learning.

Participation: Referring to different models of participation experienced at the world congress, the children demand an environment in which they can fulfil their dreams without pressure. They demand that public institutions hear them and acknowledge that they as well need to be capable of listening. Also, they demand to have child and youth representatives in institutions and be involved in decision making processes and that all action is underpinned by mutual respect. The key to effective participation is related back to education and schooling, where the foundation for participation should be laid. The declaration ends with: "As protagonists of today's and the future world we children and young people raise our voices and emphasise our right to participation, by reminding of passed errors and improving them. We are subjects with own rights and write our own history."

Secretary-General's Report on forced marriage of the girl child

Pursuant to resolution 51/3 of the Commission on the Status of Women, this report gives an overview of the consideration of the issue of forced marriage at the international level, and the evolving approach for addressing it. It provides information on the legal and policy measures of States and the activities undertaken by entities of the United Nations system to address forced marriage of the girl child. The report concludes with recommendations for future action.

Juvenile Justice: Diverting child offenders from judicial proceedings

At the 3rd World Congress on Child and Adolescent Rights in Barcelona in November 2007, two papers were given which looked at the issue of diversion of child offenders from judicial proceedings. One by John Parry-Williams reviews the argument for the diversion of offenders particularly taking into account the Committee on the Rights of the Child's, General Comment No.10, April 2007, on 'Children's Rights in Juvenile Justice'.

It also gives international examples from primarily developing countries as to the different approaches being taken and raises questions as to process and monitoring.

The other by Wansley Walters, Director of Miami-Dade Juvenile Services Department, Florida, United States, gives a detailed example of what can be done in one multi-ethnic local government area through a combination of interventions including a one-stop centre, graduated assessments, targeting of first time offenders and the under 12 year olds, a prevention strategy that avoids children being arrested and on-going plans to capitalise on the progress made so far.

The results have been speedier results for children and police, a saving of \$46 million in police and court time between 2000-2007 by keeping 10,351 children out of the juvenile court system, a reduction of arrests among under 12 year olds of 50 per cent between 1998-2005 and of juveniles by 30 per cent between 1998 to 2005.

Petition to establish complaints procedure for CRC

An international call to strengthen the enforcement of the UNCRC by the drafting and adoption of an Optional Protocol to provide a communications procedure. A group of national, regional and international organisations have launched a campaign for an Optional Protocol to the CRC to establish a complaints/communications procedure. This mechanism would strengthen enforcement of the CRC, providing children and their representatives with a channel for pursuing breaches of all the rights guaranteed by the CRC. A complaints or communications procedure allows individuals, groups or their representatives, claiming that their rights have been violated by a State that is a party to a convention or covenant, to bring a communication before the relevant committee, provided that the State has recognised the competence of the committee to receive such complaints.

Update about child rights strategy

The last meeting of the Child Rights Action Group (CRAG - whose chairing was now taken over by Euronet) took place on 14 January. As a reminder: The second Forum on Child Rights which was supposed to take place in the beginning of December was cancelled. Also another steering group meeting to prepare it never took place. CRAG sent a letter to the group of Commissioners for Fundamental Rights in December 2007, "complaining" about the Commission's inaction. CRAG is now waiting for a joint response from them. CRAG will meet with Commissioner Viviane Reding soon to talk about the issue. The European Parliament has adopted its official position about the Commission's Child Rights strategy this week in plenary. Eurochild will make the final version of the report available as soon as it is ready. Social Platform Annual Conference 2007

Consultation - What Code of Conduct for lobbyists in Brussels?

The European Commission (Secretariat General) in December published its much-awaited consultation on a draft code of conduct for 'interest representatives':

http://ec.europa.eu/transparency/consultation_code/index_en.htm_The one-page document is meant to be the future Code of Conduct for all 'lobbyists' in Brussels, and an entry requirement for the public register for interest representatives. The register is expected to be launched in Spring 2008. The deadline to answer the consultation is 15 February 2008. This follows up to the European Transparency Initiative in which the European Commission proposed the establishment of a voluntary Code of Conduct and register of interest representatives. The Social Platform reacted to the Green Paper and sent a letter in July 2007 to ask the European Commission to better take into account the specificities of citizens' associations in their upcoming initiatives.
