## Child without barriers. On the human right to be a child among children. Seminar Date: 2-3 May, 2008 Location: Evangelische Fachhochschule Darmstadt

Organiser: Bundesarbeitsgemeinschaft Gemeinsam leben - gemeinsam lernen (Federal working group: living together- learning together; in cooperation with the National Coalition Germany (of which ENMCR is a member) and the Protestant University of Applied Sciences Darmstadt.

The UNCRC does specifically mention the rights of handicapped children, yet, a bit lax. What IS the rights situation though, of children who are disabled? Parents of disabled children experience quite frequently that their children are not naturally expected to show up in places "normal" children are: music schools, youth groups, sports clubs etc. Instead, children with disabilities often find themselves in social spaces they didn't choose to be in, but to which society has assigned them. By this, the distance between disabled and non-disabled members of society is strengthened. The child as subject of rights as defined in the CRC is basically inexistent. The seminar is directed to families with disabled children, to responsible persons in politics and administrations, staff of the child and youth welfare system, teachers and educators- all persons who can contribute to bringing disabled children to the middle of society- the theme is to find solutions to end the spiral of marginalization.

## The Social Capital Foundation - Malta Conference

## VII Meeting of the movement of working children and young people of Latin America and the Caribbean (MOLACNATs) in Cachipay, Colombia (report)

From March 14-21, 2008 the movement of working children and adolescents of Latin America and the Caribbean (MOLACNATs) met for the 7<sup>th</sup> time, in order to exchange experiences and bring the movement forward. Representatives from several Latin American and Caribbean countries took part as well as representatives of movements in Europe (ItaliaNATs and ProNAts). The children and young people acknowledged the reality of their movement which was founded 30 years ago in Lima, Peru and has been brought forth since. The last meeting had been held in Paraguay in 2001. In the final declaration, the protagonists confirm their claims and demands which they have always been fighting for and present different activities that have started or are planned:

In the frame of the sustainability project a three year action plan was elaborated, that aims at implementing the political and social ideals of the movement. The action plan should serve to raise the movement's profile and reputation and thereby assist the children and young people in reaching the goal of social acknowledgement. The children have committed themselves to bring forward their rights and to develop actions to reduce poverty and to improve their working conditions, as well as fighting against social exclusion and violence against children, especially against working children. The children commit themselves to take action to enable children to work in dignity and to defend this work.

In particular the children demand that:

- national governments and the populations respect their rights.
- they be listened to and are able to participate in decision making processes that affect them. As Latin American movement, the children are dedicated to a new paradigm of childhood which was developed together with the adults present at the meeting. (Children are no longer to be seen as incompetent or as pure potential for the future, but rather as subjects of rights in the present who can contribute essentially to an improvement of society. The children of the movements see themselves as pioneers of this new paradigm).

The children have also actively participated in establishing a web platform on which their reality as an organized movement is demonstrated. They want to reach an improvement of their living conditions which are based on a solidarity economy. The declaration ends with a clear statement:

The working children know themselves, what needs to be said! We are not the problem but the solution!!! Long live the dignified work of working children!!!

Since May 31, the worldwide children's radio "World Children's Radio" is on air. The inauguration was held in Berlin with child reporters of RADIJOJO! In the presence of many honourable guests and press. Since then the English stream is on air on the web 24h a day, 7 days a week. Children take you on musical trips around the world, present interviews with interesting stars or explain important themes.

#### European Children's Radio (EUCHIRA)

The European children's radio "EUCHIRA" is being established by RADIJOJO!: a multilingual web portal on European partnership projects. At the moment, 6 partner programs between elementary schools in Berlin and different parts of former Yugoslavia are being set up in cooperation with the Media Education Centre form Belgrade (Serbia). Next school year, 6 classes each from Berlin and London will cooperate. Already done are the programs of a partnership of schools and a radio station in Ratibor/Poland and of already existing partnerships between schools in Bavaria, Italy, Spain and Ireland. ## **Publications**

#### Supporting young people in Europe (Volume 2)

This monograph has two purposes. The first is to develop the framework that was initially established through a grounded reading of the material from the first seven international reviews of national youth policy conducted by the Council of Europe Youth Directorate between 1997 and 2001. This has involved a careful reading of the subsequent national and international reports produced between 2002 and 2006 to identify either issues that merit greater prominence or new issues to be addressed in the future. The outcome of this exercise is the proposal of a new framework for European-level debates on the subject of youth policy. The second purpose is, through consultation with those who took part in the second cycle of reviews, to refine further the process by which international reviews are carried out. A number of observations suggest that immediate action can be taken to improve the experience of participating in review teams and, ultimately, the quality of the international reports.

## **COMPETITION: Ibero-American Black and White Photography** [news] We want to be treated well! 1 April - 15 May 2008

Save the Children annually organises the Ibero-American Black and White Photography Contest, the aim of which is to portray a positive concept of childhood.

The theme of the 5th Ibero-American Black and White Photography Contest is the right of boys, girls and adolescents to dignified treatment, based on communication, care and respect. Boys and girls have the same rights as adults do, in addition to special rights which are established in the CRC.

All professional and amateur photographers living in Latin American country or Spain may participate. The photographs entered must be taken in any Latin American countries or Spain.

Each participant may enter a maximum of two (02) photographs. Participation is individual. No photograph can be signed by two or more authors.

The contest website (<a href="http://concurso.savethechildrenla.org/">http://concurso.savethechildrenla.org/</a>) is the place where participants can register and upload their photographs.

Photographs should focus on the theme of the contest 'We want to be treated well!', showing in a creative way the children's right to receive a good treatment. It is recommended to show a richness of races, cultures, ages and activities performed by boys and girls of the region. It is recommended not to show images of children in unfavourable circumstances, in peril, threat of violence, or death.

Only black and white photographs will be accepted. The deadline for the reception of photographs will be **Thursday 15 May 2008**, at 21:00 hrs in Peru (+05:00 GMT). The photograph which obtains first place will be awarded US\$ 800. Visit the website for information on other prizes.

## **Stop Child Trafficking International Congress**

#### Date: 7-9 May 2008 Location: Valencia and Castellón, Spain

Fundación Tierra de Hombres Spain (People's Earth Foundation Spain) and Fundación por la Justicia (Foundation for Justice), non-profit organisations and professionals in Child Rights defence, will be the hosts of the conference. From this open and plural academic space, they would like to analyse and discuss this grave violation of children's rights, and the possible solutions that could be implemented to make society and the actors of major significance aware of it. This event will be one of many to commemorate the 60th anniversary of Universal Declaration of Human Rights. During this second congress, participants will study the conclusions arrived at in 2004 in Germany, where the last congress was held.

Experts in Child Rights and Human Trafficking from around the world, representatives of the Euro-

pean Council and European Commission, specialists from the field and NGOs will attend the event. Capacity is limited and is mainly for professionals such as lawyers, social workers, psychologists, security force members, educators, members of NGOs, university students.

#### **News from Eurochild**

#### Commission Memo on Follow-up to the EU strategy on the Rights of the Child

The European Commission is engaged in the implementation of its strategy on the Rights of the Child, which was announced in its 2006 communication "Towards an EU strategy on the rights of the child". A number of actions envisaged in the communication have already been launched. The EU has developed various concrete policies and programmes on children's rights, spanning both internal and external policies and covering a broad range of issues, such as child trafficking and sexual abuse, violence against children, discrimination, child poverty, social exclusion, child labour, health and education. Some of these actions are:

- reserving the number 116000 for a single telephone number for urgent calls about missing children
- promote the introduction of a Child Alert mechanism in every member state, and use such a mechanism at cross-border level when necessary
- currently setting up a mechanism to stop payments made with a credit card or an electronic payment when purchasing images of sexual abuse of children on the Internet
- a study on the design of indicators concerning children's rights and on relevant data sources
  was launched recently and is monitored with the help of the European Agency on Fundamental Rights
- recent adoption of a communication on Children in External Action, which places children at the centre of the EU's external relations, development and humanitarian aid policy
- Safer Internet Day on 12 February 2008 (supported by the Commission)
- the global trade association for mobile operators has launched the Mobile Alliance against Child Sexual Abuse Content to obstruct the use of the mobile environment by individuals or organisations wishing to consume or profit from child sexual abuse content (supported by the Commission)

## Call for contributions final colloquium of the "European Year of Intercultural Dialogue"

During the French EU Council Presidency at the 17./18.th November 2008 a final colloquium of the European Year of Intercultural Dialogue will be held under the patronage of the European Commission in Paris. This event aims to establish a common understanding of the perception of intercultural dialogues in Europe. Further recommendations of action for a cultural and political strategy on EU-level are supposed to be compiled to encourage an intercultural dialogue within Europe and between the EU and the rest of the world. Contributions for the final colloquium should either deal with theoretical approaches to this issue or display analyses of best practice.

#### DAAD (Germany) Subject-related partnerships with universities in developing countries
